Sir,

With reference to the correspondence resting with your letter dated: - 21.8.91 on the subject cited above, I am directed to convey the approcal of the Competent Authority for the upgradation of the existing Secondary school to Sr. Secondary level in three streams i.e. Science & Commerce &Arts without aid during the academic session 1991-92 subject to the fulfilment of the following conditions and terms:-

- That the school shall abide by the procision of Delhi School ٦٠ Mducation Accordand Rules, 1973 and other instrucations of the Depth. issued from time to time.
- That the school shall appointment qualified and within the 2. prescribed age limit PGTs in the prescribed pay scale in the subjects of Science, Commerce & Art and the list to the Deptt. for scrutiny.
- That the school shall admit the students without any discrimination of caste and creed.
- That the school shall equip the Science Labs, in accordance Ą. with the norms laid down by the Department and a sum of Rs. 60,000/- will be spent during 1991-92 to equip Science Labs.
- A proper library with number of books as prescribed by the Dept 5. will be equipped during 1991-92
- That the school shall strictly adide by the provision of De 5.**.** School Education Act and Rules, 1973 and payment of pay and allowances and other facilities will be made to the staff as per Section 10(1) of Delhi School Education Act, 1973 to all its employees.
- That facilities as required under Rules 50 & 51 of Delhi 7 . School education Rules, 1973 shall be made available. Provision of Rules 6,7 & 8 be strictly observed.
- That no unqualified of overage staff may be allowed to 8.
- That the staff should be paid their salary through crossed 9, cheques.
- 10. That the school shall create a Reserve Fund of Rs. 40,000/in the joint name of the Manager and DDE (Distt South ) immediate:

- That he Managing Committee of the School shall nottincrease fee in future academic session without prior approval of the Director of Education, Delhi.
- 12. That the service contract between the Management and the employees shall be executed immediately,
- That no unrecognised classes shall run in the school premises Nursery classes may not run in the school building.
- That the school shall per arrears and other benefits to its employees as per Recommendation of the 4th Pay Commission.
- 15. That the violation of any instructions/conditions/rules and reglations of the Department shall lead to the withdrawal of recognition of the school.
- 16. Compliance report of the above conditions may be submitted to this office latest by 30.1.92.
